Pledge Intention-CONDITIONAL PLEDGE

A pledge intention is a written or verbal commitment by an individual or organization to provide funding or support for a specific cause or organization at some point. A pledge intention serves as a promise to donate but does not legally obligate the donor to follow through with the donation. The pledge intention allows the recipient organization to plan and budget for the expected support while also allowing the donor to commit to supporting the cause without being locked into a specific amount or timeline. Pledge intentions are commonly used in fundraising campaigns and followed up with more specific requests for donations or further information on the terms of the pledge. A pledge intention can be a valuable tool for securing future support and provides a basis for continued communication between the donor and the recipient organization.

Conditional Pledge A conditional pledge is a type in which the donor commits to provide funding or support for a specific cause or organization, but only under certain conditions. The conditions may include:

- specific milestones, 1. FIRE STATION AT OLOWALU IS IN SERVICE
- meeting certain performance metrics, or 2. PROPERTY INSURANCE PREMIUMS ARE REDUCED WITH LOWER RISK AFTER 6 MONTHS OF OPERATIONS RESULTING IN UP TO 50% REDUCTION IN PREMIUM COVERAGES SAVING THOUSANDS OF DOLLARS ANNUALLY.
- 3. FUNDS SENT IN SUPPORT BASED UPON ACTUAL SAVINGS ANNUALLY OR UNTIL PLEDGE TOTAL IS MET AND SATISFIED. OR other agreed-upon criteria being satisfied.

Typically, you make a conditional pledge in advance. It provides the recipient organization with an understanding of the funding that may be available while also allowing the donor to have some control over the use of the funds. The conditions of the pledge must be met for the funding to be released and can help organizations to plan and budget for expected support.
